(Purpose of Tourism (NOT for visiting relatives/friends) - For stays of more than 24 hours up to 90 days)

Please **do NOT** staple/clip/tab/put sticky notes on documents

Each applicant must submit each own set of documents

We do NOT make copies

<input type="checkbox"/>	1. VALID ORIGINAL PASSPORT and ONE COPY OF PASSPORT'S MAIN PAGE * Passport must have at least one completely blank visa page.

ONE COMPLETED VISA Application Form (For nationals of Russia, Ukraine, Belarus, Georgia and other CIS nationals: <u>TWO Application Forms</u>) * Please type or print legibly in black/blue ink (no pencil). * Please do not leave any questions blank (Please write N/A if the question does not apply to you). * Your signature must match your passport signature. Please write E-MAIL address on form.
<input type="checkbox"/>	3. ONE PHOTO stuck to application form (45 mm x 35 mm) /Front shot/White background/ Taken within the past 6 months) (For nationals of Russia, Ukraine, Belarus, Georgia, and other CIS nationals: Two identical photos)
<input type="checkbox"/>	4. COPY of Polish Residence Card or Polish D-type Visa (Please submit copies and original to verification. Copies must be clear and legible.)
<input type="checkbox"/>	5. FLIGHT TICKETS RESERVATION that must show your arrival(s) into Japan from Poland and your departure(s) from Japan to any country. The itinerary must be from a website or airline company. PLEASE NOTE: We are not responsible for purchased flight tickets, which are unusable due to delay or denial of visa.

*** All documents must be written in English or Japanese.**

*** Please submit a set of documents for each applicant. You may not share your documents. We do not make copies.**

*** All documents must show your full name. We may request additional documents.**

*** In case of lack of required document, visa application is not accepted.**

*** Visas take a minimum of 5 business days to process, please apply for your visa ahead of time.**

*** Our office does not offer expedited services.**

*** This visa is valid for 3 months once issued to enter Japan.**

*** Please note that we issue only single entry visas for these types of travel documents.**
